

Privacy Notice

Business card delivery / Global address database

Stadler is a system provider of mobility solutions in railway vehicle construction, service and signalling technology. This Privacy Notice informs you about the processing of personal data by the company of the Stadler Group listed below (hereinafter referred to jointly as "Stadler", "we" or "us") in connection with the use of this website.

1. Controller and data protection officer

2. Personal data processed, purpose of data processing and legal basis

When we enter your business card in our global address database, we process certain personal data about you that you have provided to us on the business card and in the personal interview itself. This includes your name, employer, position and business email address. In addition, your product interests may have been requested. The global address database is used by Stadler and its affiliated companies to build and maintain customer relationships (invitations to trade fairs/events, Christmas cards, thank you notes, etc.).

3. Data transfer to third parties

We only disclose this data to third parties where this is necessary to achieve the purposes set out in section 2 or to protect our legitimate interests or where required by law. Third parties to whom we disclose data (or who may have access to the data through their service) include in particular:

- Companies of the Stadler Group (including Group companies outside the EEA, a list of the relevant companies is available at the following link: <u>Locations - Stadler</u> (<u>stadlerrail.com</u>)
- - Event agency in the EEA region
- - Exhibition service providers (invitation tools, etc.) in Switzerland or the EU
- - Service providers, in particular providers of IT services, hosting and support, logistics service providers, CRM system providers in Switzerland and the EU
- - Order data processors

If and insofar as we involve third parties, they will only receive (access to) your data to the extent that this is necessary for their corresponding service.

If data is transferred to a country that does not have an adequate level of data protection, the data is protected accordingly, namely by means of standard contractual clauses approved by the European Commission and recognised by the Federal Data Protection and Information Commissioner.

4. Retention period

We will retain your data for as long as you maintain your consent to processing. You can notify us of the withdrawal of your consent at any time via <u>Reply_Address_Database_Sales@stadlerrail.com</u>.



5. Your rights

To the extent provided for by applicable data protection law, you have the right to request access to your personal data, to require that your data be rectified or completed, to have processing restricted or data erased, and to receive your data in a structured, commonly used and machine-readable format in order to transmit this data to another location (data portability).

Furthermore, you may object to the processing of your personal data if we are not obliged to process it for the performance of a contractual or legal obligation. If processing of your data is based on your consent, you may, at any time, withdraw it. Please note that the withdrawal of your consent will not affect the lawfulness of previous processing.

Your rights may be restricted, in particular if the exercise of your rights conflicts with the performance of our legal or contractual obligations, or where we can demonstrate an legitimate interest in processing, or the rights of third parties would be infringed.

If you believe your rights have been infringed, you may, at any time, lodge a complaint with the competent supervisory authority. In Switzerland, this is the Federal Data Protection and Information Commissioner
